## DNR Board Approves Phosphorus Limits in State Waterways

The goal is cleaner water, fewer algae blooms and a better habitat for fish and other aquatic life. Phosphorus pollution from runoff is one of the contributing factors to the foul-smelling algae on Lake Michigan's beaches. The regulations take a two-pronged approach by setting water quality standards for phosphorus and putting new limits on municipal wastewater treatment plants and factories with their own treatment systems.
